Conditions of Employment:

- Must be legally entitled to work in Canada.

- Must be registered or eligible for registration as a Professional Engineer with Engineers Geoscientists Manitoba
- Must have a valid Manitoba Class 5 Drivers License with access to a vehicle.
- Must be able to work in an outdoor rough terrain environment, including near or on water, in both winter and summer in extreme temperatures.
- Must be physically capable of performing the duties and functions of the job including working at outdoor work sites, in confined spaces and extreme heights, and carrying out physical activities such as standing, sitting, walking, climbing, twisting, slip-trip-fall, lifting and carrying (0-22 lbs)
- Must be able to travel throughout by ground and air transportation and be away from home for extended periods.
- Must be able to work extended hours as required.
