## Position Purpose

This position provides leadership, direction and professional expertise to a team responsible for engineering, planning, and operational support functions related to the safety and regulatory requirements of the 23 Dams within Integrated Water Services.

## Key Accountabilities/Position Outcomes

- Provides senior level engineering, planning and operational expertise, including:
  - Long range planning and implementation of dam safety improvements to ensure regulatory compliance and risk management.
  - o Plan, develop, implement and maintain a formal Dam Safety Management System
  - Review, develop and maintain the Dam Emergency Plans and Dam Safety Risk Registry for Integrated Water Services
  - o Prepare staff reports, presentations and grant applications.
  - Provide strategic direction and supports budget and resource planning for dam safety related work.
- Assumes managerial responsibility for the scope of work, and exercises authority over staff and
  consultants as necessary to ensure efficient delivery of capital projects and compliance with relevant
  legislation, guidelines, agreements, policies, and procedures.
- Provides leadership to work collaboratively with senior staff to provide advice on dam owner obligations and initiatives. Represents Integrated Water Services in communication with provincial dam safety regulators.
- Ensures policies, procedures, bylaws, plans, systems, resources and management practices are in place to support and ensure the successful delivery of projects and initiatives.

- Ensures Capital Projects are defined and completed with a commitment to project deliverables and organizational objectives as well as an ongoing commitment to project management principles.
- Provides a strategic lens in the planning and leading of consultants to ensure efficient delivery of multiple capital projects, e.g. bundling work projects.
- Assists with the preparation of Divisional operating and capital budgets, tracking, monitoring and controlling budgets for areas of responsibility.
- Uses leadership, coaching and management skills to create a highly engaged team of professional and technical staff to ensure division goals and objectives are achieved.
- Uses diplomacy and strong communication, presentation and relationship building skills to create and maintain collaboration among internal and external stakeholders.
- Provides leadership and participates in responding to potential dam safety emergencies.
- Provides Professional Engineer sign off for engineering planning and design work, as required.
- Responsible for the leadership and management of employees and contractors within area of
  responsibility, including employment and labour relations matters involving: employee hiring, promotion,
  demotion and other personnel matters; discipline and discharge; representing management in the
  grievance procedure; input on behalf of management into labour relations matters, and representing
  management on committees; maintaining Employer confidentiality; and developing, supporting and
  implementing various corporate and legislated policies, procedures and practices.
