**ORDER OF THE INVESTIGATION COMMITTEE**

**WHEREAS** John Rocke, P. Eng. (“Mr. Rocke”), of the City of Winnipeg, Province of Manitoba, is registered as a professional engineer in the Province of Manitoba;

**AND WHEREAS** on or about December 08, 2020, Engineers Geoscientists Manitoba (“EGM”) received a complaint against Mr. Rocke.

**AND WHEREAS** the complaint against Mr. Rocke was reviewed and investigated by the investigation committee, following which the investigation committee concluded that Mr. Rocke had committed professional misconduct or unskilled practice of professional engineering;

**AND WHEREAS** on or about March 15, 2022, the investigation committee formulated a draft charge and penalty against Mr. Rocke, and thereafter, consulted with a member of the discipline committee of EGM regarding the appropriateness of the penalty;

**AND WHEREAS** Mr. Rocke consents to the registration of a conviction in relation to the aforementioned charge and the imposition of the aforementioned penalty;

**AND WHEREAS** pursuant to section 35(1)(f) of *The Engineering and Geoscientific Professions Act*, C.C.S.M. c. E120, the investigation committee may, after review or investigation of a complaint, and with the written consent of the investigated person, formulate a charge, register a conviction and impose any penalty that the discipline committee could have imposed;

**NOW THEREFORE BE IT RESOLVED AND ORDERED ON THE WRITTEN CONSENT OF JOHN ROCKE THAT:**

1. Mr. Rocke be and is hereby convicted on the charge attached hereto at **Appendix ‘A’**;
2. Mr. Rocke be and is hereby reprimanded;
3. Mr. Rocke be and is hereby ordered to pay fifty (50) percent of the costs associated with the review by Woodall Structural Engineering, in the amount of \$2636.00; and
4. Mr. Rocke’s name and the circumstances relevant to the finding of professional misconduct or unskilled practice of professional engineering shall be published in accordance with EGM’s policy on publication.

**CHARGE**

The Investigation Committee of the Association of Professional Engineers and Geoscientists of the Province of Manitoba formulates the following charge.

**John L. Rocke**, P.Eng., while registered as a professional engineer in the Province of Manitoba, displayed conduct which constitutes professional misconduct or unskilled practice in that:

In the course of providing engineering services for structural renovations to the residence at 623 Langevin St. in Winnipeg, Mr. Rocke displayed a lack of knowledge of or lack of skill or judgment in the practice of professional engineering, in violation of s. 46(1)(e) of *The Engineering and Geoscientific Professions Act*.

Particulars

On or about September 24, October 12 and October 26, 2020, Mr. Rocke sealed drawings for structural renovations to the residence at 623 Langevin St. in Winnipeg, which involved the removal of a partition wall to open the main floor of a residence. In the course of providing structural engineering services, Mr. Rocke:

1. Failed to include sufficient detail to ensure safe construction and to enable the design to be checked, and
2. Issued a design that was not in accordance with good engineering practice and the required standards or codes.
